The Toolsets

- Health & Social Care a comprehensive, integrated documentation system for health and social care. Contains over 40 generic and specialist tools supporting integrated health and social care working. Accredited by the Department of Health, CAF-compliant and used in over half the country.
- Mental Health a complete documentation system for mental health services, including tools for Adult Mental Health, Older People's Mental Health, Young People/CAMHS and Perinatal Services. Complies with all national data requirements and incorporating CPA assessment, Risk assessment and a wide range of outcome measures.
- **Risk** risk assessment and risk management tools for Mental Health, Older People, Learning Disabilities, Perinatal Services, Substance Misuse and Young People.
- Learning Disabilities a complete documentation system for people with learning disabilities, including specialist tools for people who also have mental health problems and epilepsy.
- Young People* specialist tools for young people/CAMHS. Includes a holistic assessment for young people with complex needs and a dedicated risk assessment.
- **Substance Misuse** specialist toolset for Addiction services, including core assessment, risk assessment, substance use history and forensic history.
- Mental Capacity & DOLS* assessment tools meeting all legal requirements of MCA and DOLS.
- Telecare* specialist toolset for telecare evaluation, prescription and outcomes monitoring.
- **Person-held Record** purpose-designed personal record folder for holding FACE documents in the home.

What is a FACE toolset?

Every FACE toolset is a complete documentation system tailored to the needs of the relevant care group. The toolsets include both generic and specialist tools and support:

- Personal goal achievement


Use of these measures is supported by academic collaborations and centralised databases.


Outcomes software

The software provides accessible, immediate feedback at individual service user, practitioner, management and strategic levels. Attractive graphs and charts provide views of both high-level and in-depth outcomes for both individuals and groups, whilst the software calculates all the basic statistics required for routine purposes.

The software also allows you to compare and benchmark the outcomes of any required team, group or intervention e.g. the graph below suggests that patients on Oak Ward seem to improve more than patients for Hillside Hospital as a whole.





Paper and electronic use

FACE tools may be completed either on paper or electronically. Our clinical software enables easy collection, printing and analysis of all FACE tools and FACE tools are also available from most major health and social care software suppliers. The tools can also be completed on mobile devices such as digital pens.

Training and support

We take a personal interest in helping you make best use of FACE tools. Our helpdesk is just a call or email away. The customer area of the website enables users to provide feedback, make suggestions for change, report problems or download drafts of new developments. Your feedback is always welcome!

All toolsets include high quality supporting documentation and training materials and we provide on-site training for new users of the tools, through our network of experienced FACE trainers.

In addition, we run a central training programme for people who wish to become 'expert users' of FACE. This course is designed for senior practitioners or trainers who will be taking a lead in implementing FACE in their organisation.
